Business Blueprint Participation Agreement

- 1. This Agreement is between you and Dream Express International Pty Ltd (ACN 115 281 420) (us, we or our) and relates to your participation in our program known as "Business Blueprint" (Business Blueprint).
- As a member of Business Blueprint you understand information, techniques, skills and concepts shared by trainers and speakers and all
 audio and video recordings, on-line training videos, information, manuals, checklists, documents, websites and other materials (*Program Materials*) are not to be relied on as any type of professional or other advice.
- 3. Business Blueprint and the Program Materials may only be used for educational purposes and only for non-commercial use.
- 4. During sessions, some speakers may choose to share with you private information that they do not want repeated outside the Business Blueprint environment. If informed, please be respectful and refrain from discussing such information outside the environment.
- 5. Recording equipment of any kind is not allowed during Business Blueprint events. An official recording will be made by us and once edited it will be uploaded to the my.BusinessBlueprint.com website.
- 6. Business Blueprint, the Program Materials, and user names and passwords provided to you are confidential and must not be given to or shared with people outside the Business Blueprint community. The only exception to this is you may share relevant information with your staff for the purposes of them implementing the ideas shared into your business.
- 7. No part of Business Blueprint or the Program Materials may be copied, modified, licensed, published, transmitted, distributed, uploaded, broadcast, sold or otherwise transferred without our prior consent. We or our licensors own all intellectual property rights in Business Blueprint and the Program Materials.
- 8. Business Blueprint is a 12-month program. Payments must be made at the beginning of each calendar month. There are no cancellations, hold-periods or refunds during this time. Should your credit card expire, you will be required to supply new details that will take you up to the end of the agreed payment period. We reserve the right to suspend your access to the program until your payments are up to date. During this initial 12 month period we reserve the right to assess individual memberships in cases of extenuating and or extraordinary circumstances and if an early termination of membership is agreed upon by both parties in writing, a contract exit fee of \$2,500 will be charged and payable to Dream Express International Pty Ltd within 7 days.
- 9. After your first 12-months your membership will automatically be renewed and will continue until it is cancelled. At the start of your second year your membership will be upgraded to VIP and your payments will be reduced to \$695 per month for Gold Members, and a low \$1,195 per month for Platinum Members. Should you continue into a third year, payments will reduce even further to just \$495 per month for Gold Members, and just \$995 per month for Platinum Members.
- 10. Should you at anytime wish to upgrade your membership from Blueprint Gold to Blueprint Platinum, please send an email notifying us.

 Once received we will make the necessary administration and accounts changes. From there you will be emailed a confirmation letter that will include access details to all Business Blueprint Platinum privileges.
- 11. To further support you, business partners are able to join Business Blueprint at the same membership level as you and take advantage of a special discounted rate. The discount is equal to 50% off the standard Platinum investment, or 25% off the standard Gold investment. To qualify proof of a business partner relationship must be supplied. This discount doesn't apply to family/life-partners in separate businesses.
- 12. After your first 12-months, should you wish to cancel your membership, please send us an email providing a minimum 2-weeks notice. By doing so we can ensure no further charges take place.
- 13. After your first 12-months of membership, you may cancel your membership. Simply send us an email 14-days prior to your next payment date. You will then be contacted to confirm this action and your login details for my.BusinessBlueprint.com will be suspended at the end of your payment cycle. We can cancel your membership if you are in breach of this Agreement.
- 14. With regards to all Blueprint Conferences, all conference fees and materials are included. However, flights, accommodation, meals (including Gold & Platinum Dinners), drinks and all other expenses are the responsibility of the Business Blueprint member.
