Business Blueprint Ruby Pass Agreement

1. This Agreement is between you and Dream Express International Pty Ltd (ACN 115 281 420) (**us, we or our**) and relates to your participation in our Ruby 3 Month program known as "Business Blueprint" (**Business Blueprint**).
2. As a member of Business Blueprint you understand information, techniques, skills and concepts shared by trainers and speakers and all audio and video recordings, on-line training videos, information, manuals, checklists, documents, websites and other materials (**Program Materials**) are not to be relied on as any type of professional or other advice.
3. Business Blueprint and the Program Materials may only be used for educational purposes and only for non-commercial use.
4. During sessions, some speakers may choose to share with you private information that they do not want repeated outside the Business Blueprint environment. If informed, please be respectful and refrain from discussing such information outside the environment.
5. Recording equipment of any kind is not allowed during Business Blueprint events. An official recording will be made by us and once edited it will be uploaded to the my.BusinessBlueprint.com website.
6. Business Blueprint, the Program Materials, and user names and passwords provided to you are confidential and must not be given to or shared with people outside the Business Blueprint community. The only exception to this is you may share relevant information with your staff for the purposes of them implementing the ideas shared into your business.
7. No part of Business Blueprint or the Program Materials may be copied, modified, licensed, published, transmitted, distributed, uploaded, broadcast, sold or otherwise transferred without our prior consent. We or our licensors own all intellectual property rights in Business Blueprint and the Program Materials.
8. Payment will be made at the beginning of your 3 month Ruby Pass membership. This will be via a deposit of \$495 via credit card and the balance of \$1,500 via EFT within 7 days. There are no cancellations, hold-periods or refunds during this time. Should your credit card expire, you will be required to supply new details that will take you up to the end of the agreed payment period. We reserve the right to suspend your access to the program until your payments are up to date.
9. Communication will be via email from this point forward. Should you wish to continue your membership, you will confirm this in writing via email and all communication about your membership and the terms of this agreement will be via email. Should you chose to continue your membership with us, the terms and conditions in this agreement will roll over and continue to apply.
10. During your 3 month access period, you will receive the same full benefits that our Platinum Elite members receive, with the only exception being no access to the Blueprints in my.businessblueprint.com which are only available to Platinum Elite members on a 12 month membership. If you choose to stay on as a Platinum member, your membership level will be upgraded and you will then unlock full access to all Platinum member benefits including 250 Blueprints.
11. To further support you, once you renew your membership as a full membership, business partners are able to join Business Blueprint at the same membership level as you and take advantage of a special discounted rate. The discount is equal to 50% off the standard Platinum investment, or 25% off the standard Gold investment. To qualify proof of a business partner relationship must be supplied. This discount doesn't apply to family/life-partners in separate businesses.
12. After your 12-months, should you wish to cancel your membership, please send us an email providing a minimum 2-weeks notice. By doing so we can ensure no further charges take place.

You will then be contacted to confirm this action and your login details for my.BusinessBlueprint.com will be suspended at the end of your payment cycle. We can cancel your membership if you are in breach of this Agreement.
